- All sums or dues whatsoever owing to the Developer and/or Proprietor and/or State Authorities and/or relevant bodies and all fees, charges and expenses in connection with C. incidental to or pursuant to the said application for approval or consent or confirmation shall be solely borne and paid by the Purchaser.
